

RESOLUTION NO. 3219

RESOLUTION AUTHORIZING THE MAYOR TO SIGN AND SUBMIT A
"TRANSIT AGENCY SALES TAX COLLECTION CERTIFICATION FORM",
AND FURTHER CONFIRMING THE CITY COUNCIL'S INTENT TO NOT
DELAY, DIVERT, SUPPLANT OR SUSPEND COLLECTION OF APPROVED
LOCAL SALES AND USE TAXES THAT ARE FOR THE PURPOSE OF PUBLIC
TRANSPORTATION DURING THE STATE'S 2025-2027 FISCAL BIENNIA

WHEREAS, During the recently-concluded 2025 state legislative session, Engrossed Substitute Senate Bill (ESSB) 5161 was passed by the legislature, only partially vetoed by the Governor, and the un-vetoed portion thereof then became a law following a signature thereon by the Governor; and

WHEREAS, ESSB 5161 became a law via the session laws, specifically within Chapter 416, Laws of 2025; and

WHEREAS, the item contains the state's transportation budget for the current state 2025-2027 fiscal biennium. Accordingly, ESSB 5161 did not create or modify a portion of the RCWs (whereas a change to the RCWs typically does occur when session laws are enacted for non-budget actions); and

WHEREAS, within ESSB 5161, the state imposed a new certification requirement for municipalities that seek various grants from WSDOT. In short, it is now a prerequisite to potential award of certain grants that the grant-seeking municipality must certify that it will not stop collecting on any existing local sales or use taxes that are for the purpose of public transportation. Stated inversely, the municipality must promise to keep collecting on those local taxes, as a prerequisite to potentially being awarded grants from WSDOT; and

WHEREAS, the state has transmitted a "Transit Agency Sales Tax Collection Certification Form" and has asked the City to sign and return it; and

WHEREAS, the terms of the form are acceptable to City staff and City staff has sought approval from the City Council for the Mayor to sign and submit it; and

WHEREAS, in addition to having the Mayor sign and submit the form, the City Attorney believes that the City Council should further confirm, directly on its own behalf, that the City Council's current intent is not to negate or lessen any local sales or use taxes related to public transportation between now and the end of 2027; and

WHEREAS, the City Council finds that good cause exists;

Section 1. Mayor Authorized. The Mayor is authorized to sign and submit to WSDOT the "Transit Agency Sales Tax Collection Certification Form" in the form appended hereto.




