

RESOLUTION NO. 3263

RESOLUTION AUTHORIZING THE MAYOR TO SIGN A ONE-PAGE ADDENDUM TO THE EXISTING INTERLOCAL AGREEMENT WITH THE CITY OF SUNNYSIDE FOR CORRECTIONS/DETENTION SERVICES, WHICH WILL APPLY DURING 2026

WHEREAS, the City Council approved Resolution No. 2676 on May 22, 2018, authorizing the Mayor to sign an eleven-page Interlocal Agreement (labeled Interlocal Agreement Between the City of Sunnyside, Washington and City of Selah, Washington, for the Housing of Inmates) whereby the City would be able to obtain corrections/detention services from Sunnyside during 2018 and 2019; and

WHEREAS, successive one-year amendments (each labeled an “Addendum”) to the Interlocal Agreement were subsequently entered into between the parties for the respective years of 2019, 2020, 2023, and 2024 (and potentially other years, also) to revise the monetary rates that apply during each year; and

WHEREAS, Sunnyside has proposed a new one-page Addendum, which would specify the monetary rates that will apply during 2026; and

WHEREAS, the now-proposed one-page Addendum has been reviewed by the City Attorney, and its terms are acceptable to City Staff; and

WHEREAS, City staff recommends that the now-proposed one-page Addendum be approved and entered into; and

WHEREAS, the City Council finds that good cause exists;



**INTERLOCAL AGREEMENT BETWEEN THE CITY OF SUNNYSIDE, WASHINGTON
AND THE CITY OF SELAH, WASHINGTON, FOR THE HOUSING OF INMATES**

ADDENDUM

THIS ADDENDUM TO OUR INTERLOCAL AGREEMENT (hereinafter referred to as "Addendum") is made and entered into by and between the City of Sunnyside, Washington and the City of Selah, Washington;

WHEREAS, the City of Sunnyside and The City of Selah already have an existing Agreement for the housing of inmates;

WHEREAS, the City of Sunnyside desires to further modify the existing Agreement as set forth in this Addendum;

NOW THEREFORE, in consideration of the mutual covenants, condition and promises contained herein, the parties hereto mutually agree as follows:

SECTION 6(a) COMPENSATION shall be repealed and replaced with:

(a) Rates. Sunnyside agrees to accept and house Selah inmates for compensation per inmate at the rate of \$76.59 per day. The date of booking into the Sunnyside Jail of any Selah inmate shall be charged a minimum of a full daily rate per inmate regardless of the time of booking within a 24 hour period. The date of release from the Sunnyside Jail and/or returned to Selah, regardless of the time frame within a 24 hour day shall not constitute a charge by the City of Sunnyside against the City of Selah.

This Addendum shall be effective from January 1, 2026 or once fully endorsed by both parties, whichever is later.

The remainder of the original Agreement remains unchanged.
